A BILL
ENTITLED

AN ACT concerning

The 2006-2007 Current Expense Budget
Gifts and Grants Special Revenue Fund
Public Health Emergency Preparedness Base Grant

FOR the purpose of amending the 2006-2007 Current Expense Budget, by appropriating to the
Gifts and Grants Special Revenue Fund monies derived from federal funds and
made available to the County through the Maryland State Department of Health and
Mental Hygiene Office of Preparedness and Response.

WHEREAS, the Maryland State Department of Health and Mental Hygiene
Office of Preparedness and Response has made an award of federal funds available to
the Baltimore County Department of Health to provide communications equipment,
purchase medical supplies for emergency response, develop and print a calendar, provide
training, and support existing activities; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2007, be and is hereby amended by appropriating federal funds made available to the Baltimore County Department of Health, in the amount herein specified, to the following program:

005-030-30CX Public Health Emergency Preparedness Base Grant \$112,992.00

SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by the affirmative vote of five members of the County Council, shall take effect March 18, 2007.
