#### A BILL ENTITLED

#### AN ACT concerning

Distribution of Tobacco Products to Minors

FOR the purpose of prohibiting the sale or distribution of tobacco products to minors; defining terms; providing exceptions; regulating the display of tobacco products; providing for penalties and for enforcement; and generally relating to the regulation of the distribution of tobacco products to minors.

#### BY adding

Sections 13-12-101 to 13-12-105 Article 13 - Public Health, Safety and the Environment Title 12 - Distribution of Tobacco Products to Minors Baltimore County Code 2003

- 1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY,
- 2 MARYLAND, that Sections 13-12-101 to 13-12-105 be and they are hereby added to Article 13 -
- Public Health, Safety and the Environment, Title 12 Distribution of Tobacco Products to Minors, of

- 6 (A) ANY PERSON WHO OWNS OR OPERATES A BUSINESS THAT ENGAGES IN THE
- 7 RETAIL SALE OF A TOBACCO PRODUCT MAY NOT STORE OR DISPLAY TOBACCO
- 8 PRODUCTS UNLESS SUCH PRODUCTS:
- 9 (1) ARE NOT IMMEDIATELY ACCESSIBLE TO CUSTOMERS; AND

- SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect 45 days
- after its enactment.
