On page 3, in line 1, strike "THAT" and substitute "THAT, WITHIN A 6-MONTH PERIOD,"; also in line 1, strike "ACTIVITIES" and substitute "INCIDENTS"; strike from "ATTEMPT" in line 4, through "SECTION" in line 8 and substitute "PROVIDE NOTICE OF THE PUBLIC NUISANCE INCIDENTS TO THE PROPERTY OWNER IN ACCORDANCE WITH § 3-6-203(C) OF THE CODE"; in line 9, strike "(3)" and substitute "(2)", in line 10, strike "NUISANCES" and substitute "NUISANCE INCIDENTS"; in line 12, after "NUISANCE", insert "INCIDENT"; and in line 19, strike "APPEAL" and substitute "HEARING".

3. On page 4, in line 4, strike "CODE ENFORCEMENT" and substitute "BOARDING- OR ROOMING HOUSE" in line 8, strike "CODE OFFICIAL SHALL BE DEEMED TO HAVE FAILED TO MEET THIS STANDARD" and substitute "HEARING OFFICER MAY DECLINE TO DENY, SUSPEND, OR REVOKE A LICENSE"; in line 12, strike "ACTIVITY" and substitute "INCIDENTS"; also in line 12, strike "IS" and substitute "ARE"; in line 13, strike "ACTIVITY" and substitute "INCIDENTS"; in line 14, strike "ALL NECESSARY" and substitute "REASONABLE"; in lines 16 and 18, strike "ACTIVITY" and substitute "INCIDENTS"; in line 19, strike "ALL" and substitute "REASONABLE"; also in line 19, strike "NECESSARY"; after line 19, insert "(4) THE HEARING OFFICER MAY DECLINE TO DENY, SUSPEND OR REVOKE A LICENSE FOR ANY REASON THAT JUSTICE REQUIRES."

In using this document, the Design Professional shall not be relieved of the responsibility of applying his own knowledge and professional judgement toward the designs.

Waivers or Variances

Waivers or variances of these design guidelines may be approved, by the Director of Public Works or his designee, on the basis of a justification/analysis which will include but not be limited to life cycle costs, maintenance requirements, context sensitive considerations or other local considerations."

2. On page 1 of the "Water Main Design Standards" section of the Manual, in paragraph B., strike beginning with the third sentence down to and including the end of the paragraph.

3. On page 3 of the "Wastewater Collection and Pumping" section of the Manual, in paragraph G., strike beginning with the third sentence down to and including the end of the paragraph.
