D. <u>INTRODUCTION OF BILLS</u>

BILL 69-11, entitled An Act for the purpose of approving the execution and delivery by Baltimore County, Maryland of a conditional purchase agreement, in an amount not to exceed \$25,000,000 in order to finance the costs of an upgrade to or replacement of an existing transfer station and the procurement and installation of a single stream recyclables processing system within an existing commercial material recovery facility and material recycling facility, in each case located at Texas Acceptance Facility in Cockeysville, Maryland; providing that the County's obligation to make purchase installment payments under the Conditional Purchase Agreement shall be subject to annual appropriation by the County Council and shall not constitute indebtedness of the County; and generally providing for other matters related to the execution and delivery of the Conditional Purchase Agreement by the County.

- 2. On page 2, in lines 2 and 3, strike "Sections 306 and 712(a)" and substitute "Section 716"; strike from the second "and" in line 3, through "amended," in line 4; in the same line, strike "Current Expense" and substitute "Capital"; and in line 8, strike "Waterway Improvement Program, Back River Watershed" and substitute "Back River Watershed Restoration".

Councilman Quirk seconded the motion and these amendments passed by the following roll call vote:

F. APPROVAL OF FISCAL MATTERS

The Chairman stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on September 27, 2011. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Chairman Olszewski then called upon the Secretary to read the cover letters for Fiscal Matters 1 through 4.

1. Contracts - (2) - Taxi Cab Services - Dept. of Health and Human Services

Two contracts with Frederick Ellis, Inc., and Jimmy's II, LLC t/a Jimmy's Cab, to provide taxicab services for eligible HIV-positive Baltimore County residents to and from appointments and serices.

2. <u>Contracts - (3) - Cancer Screening, Diagnosis and Treatment Services - Health & Human Services</u>

Three contracts with Colon Rectal Surgical Associates, LLC, Lutherville Endoscopy Center, LLC, and Adelmo Marana, M.D., P.A., to provide cancer screening, diagnosis and treatment services to Baltimore County residents.

3. <u>Contract - PAC Industries, Inc. - Maintenance and repairs of Laundry Equipment - Dept. of Corrections</u>

A contract with PAC Industries, Inc., to provide all labor and materials for the maintenance and repairs of all laundry equipment for the Department of Corrections.

4. <u>Contracts - (8) - On-call Engineering Design Services - Environmental Protection & Sustainability</u>

Eight contracts to provide on-call engineering design services for stream restoration design, management and monitoring.

There being no discussion, upon motion by Councilman Oliver, seconded by Councilwoman Bevins, Fiscal Matters 1 through 4 were unanimously approved.

G. <u>MISCELLANEOUS BUSINESS</u>

1. Correspondence - Non-Competitive Awards

At the direction of the Chairman, the Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during August, 2011.

2. Res. 106-11 - Planning Board - Lighting Standards

At the direction of the Chairman, the Secretary read this Resolution of the Baltimore County Council requesting the Planning Board to review lighting standards for Baltimore County. There being no discussion, upon motion by Councilman Marks, seconded by Councilwoman Bevins, this Resolution was unanimously approved.

3. Res. 107-11 - To establish the Committee to Explore the Future of Owings Mills

This Resolution was withdrawn prior to the meeting.

4. Res. 109-11 - Property Tax Exemption - DAV - Richard J. Knauer, Jr.

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Richard J. Knauer, Jr. who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilwoman Almond, this Resolution was unanimously approved.

5. Res. 110-11 - Property Tax Exemption - DAV - James E. Dahler, Sr.

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from James E. Dahler, Sr. who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Quirk, this Resolution was unanimously approved.

6. Res. 111-11 - Property Tax Exemption - DAV - John J. Dixon

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from John J. Dixon who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Huff, seconded by Councilman Oliver, this Resolution was unanimously approved.

7. Res. 112-11 - Property Tax Exemption - DAV - David A. Hatcher

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from David A. Hatcher who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Oliver, this Resolution was unanimously approved.

8. Res. 113-11 - Property Tax Exemption - DAV - George E. Hohman

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from George E. Hohman who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Huff, seconded by Councilman Oliver, this Resolution was unanimously approved.

9. Res. 114-11 - Conditional Purchase Agreement - Single Stream Recycling Facility

At the direction of the Chairman, the Secretary read this Resolution approving the execution and delivery by Baltimore County, Maryland of a conditional purchase agreement in an amount not to exceed \$10,500,000 in order to finance the costs of certain equipment useful and necessary for the use and benefit of the County and its agencies; providing that the County's obligation to make lease payments under the Conditional Purchase Agreement shall be subject to annual appropriation by the County Council and shall not constitute indebtedness of the County; and generally providing for other matters related to the execution and delivery of the Conditional Purchase Agreement by the County. Keith Dorsey appeared. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Oliver, this Resolution was unanimously approved.

10. Res. 115-11 - Review of PUD - Shelter Development - Brightview Perry Hall - 5th District

This Resolution was for introduction only.
