#### 1. Amendment #1 to Contract - American Legal Publishing - Additional term

Amendment # 1 to the contract with American Legal Publishing, to extend the term of the original contract to add an additional 2-year term, as well as increase the total compensation amount.

#### 2. Contract - ARM Group, Inc. - Solid Waste engineering assistance - Landfills

A contract with ARM Group, Inc., to provide general solid waste engineering assistance for closed landfills and an active landfill.

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Ernest C.
