#### D. INTRODUCTION OF BILLS

#### F. <u>APPROVAL OF FISCAL MATTERS</u>

# 1. <u>Contract - Associated Catholic Charities, Inc. - Brief Strategic Family Therapy Services - HHS</u>

A contract with Associated Catholic Charities, Inc., to provide Brief Strategic Family Therapy Services for Baltimore County children and youth, ages 6-14, and their families. It is expected approximately 100 families will be served annually.

# 2. Addendum #2 to Contract - Hord Coplan & Macht, Inc. - On-call architectural services - Public Works

Addendum #2 to the contract with Hord Coplan & Macht, Inc., to provide on-call architectural services to perform preliminary design, site survey, geotch reports, cost estimates, schematic design, design development, construction document, and bid and construction administrative phase services as needed.

# 3. <u>Contract - Auston Contracting, Inc. -provide scrap tire hauling and recycling services - Public Works</u>

A contract with Auston Contracting, Inc., to provide scrap tire hauling and recycling services for the Department's Highway/Equipment Maintenance Division, at various collection sites throughout Baltimore County.
