B. APPROVAL OF JOURNAL

Upon motion by Councilman Oliver, seconded by Councilwoman Almond, the reading of the Journal Entries for the meeting of July 7, 2014 was waived and accepted unanimously.

C. <u>ENROLLMENT OF BILLS</u>

The Chair stated that the following Bills were passed by the County Council and signed by the County Executive. She certified and delivered to the Secretary, Bills 40-14 and 41-14.

D. <u>INTRODUCTION OF BILLS</u>

BILL 46-14, entitled An Act for the purpose of allowing certain former employees of the Baltimore County Public Library to join the retirement system under certain circumstances; providing that employees who join the retirement system shall be deemed as having joined before a certain date; providing for certain contributions and certain benefits; and generally relating to the ability of certain employees to join the retirement system.

BILL 47-14, entitled An Act for the purpose of amending the 2013-2014 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from private funds and made available to the County through the estate of the late Margaret Leister.

<u>BILL 48-14</u>, entitled An Act for the purpose of amending the 2014-2015 Capital Budget, by appropriating to the Capital Budget monies derived from grant funds and made available to the County through the State of Maryland.

<u>BILL 49-14</u>, entitled An Act for the purpose of amending the 2014-2015 Capital Budget, by appropriating to the Capital Budget monies derived from grant funds and made available to the County through the State of Maryland.

E. CALL OF BILLS FOR FINAL READING AND VOTE

<u>Bill 42-14</u>, Zoning Regulations - Signs, was called. Councilman Marks commented then moved to amend this Bill with the following amendments:

- 1. On page 2, in the second WHEREAS clause, strike "and Route 1"

<u>Bill 45-14</u>, CEB - Family Employment and Support Program, was called. Tim Sheridan appeared. Councilman Olszewski moved to amend this Bill with the following amendments:

1. On page 1, in the third line of the title and on page 2, in line 7, strike "Family Employment and Support Program" and substitute "Child Support Services".

2. On page 1, in the fourth line of the purpose paragraph and in the second line of the "WHEREAS" clause, strike "Circuit Court for Baltimore County" and substitute "Maryland Administrative Office of the Courts, Family Services Division"; and in the first line of the "WHEREAS" clause, strike "Services" and substitute "Resources".

Councilman Huff seconded the motion and this amendment passed by the following roll call vote:

F. <u>APPROVAL OF FISCAL MATTERS</u>

The Chair stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on July 29, 2014. The witnesses who testified at the work session were available to restate their testimony if needed. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Chair Bevins then called upon the Secretary to read the cover letter for Fiscal Matters 1 through 9.

1. <u>Addendum #3 to Contract - Gannett Fleming, Inc. - modification of final design - additional reservoirs - Public Works</u>

Addendum #3 to the contract with Gannett Fleming, Inc., to modify the final design of the site work, piping, support facilities and environmental approval submittals, to incorporate three reservoirs instead of 2, as originally proposed.

2. <u>Contract - Maryland Environmental Service - assistance with preservation, improvement & management - quality of air & water resources - Public Works</u>

A contract with Maryland Environmental Service, to provide public and private instrumentalities with services that will assist with the preservation, improvement and management of the quality of air, land and water resources, encourage reductions in the amount of waste generated and discharged into the environment and to promote the health and welfare of the citizens of the State.

3. <u>Contract - The Coalition to End Childhood Lead Poisoning, Inc., outreach & education</u> of lead hazard reduction - Planning

A contract with The Coalition to End Childhood Lead Poisoning, Inc., T/A Green & Healthy Homes Initiative, to provide outreach and education of lead hazard reduction, in an effort to make housing units lead safe for children.

4. Contracts (2) - Professional Engineering Services - shoreline erosion - DEPS

Two contracts with Moffatt & Nichol, Inc., and EA Engineering, Science and Technology, Inc., to provide professional engineering services for the design of various shoreline erosion and enhancement projects.

5. Agreement - West Group - internet legal search database - Law

An agreement with West Group, to provide an internet legal research database. The agreement locks in the current price over a three year period, and will include users from the Police Department and County Council.

6. <u>Amendments to the Contracts - (3) - individual, family and group behavioral health services - HHS</u>

Three amendments to contracts with Dundalk Youth Services Center, Inc., Lighthouse, Inc., and Center for Progressive Learning, Inc. d/b/a First Step, to add an additional one year renewal period to the existing agreements.

7. Contract - Pension Benefit Information, Inc., - death audit services - OBF

A contract with Pension Benefit Information, Inc., to provide death audit services for the Baltimore County Retirement Division.

8. <u>Amendment #2 to Contract - Bel Air Auto Auction, Inc. - auctioneering & simulcast services - OBF</u>

Amendment # 2 to the contract with Bel Air Auto Auction, Inc., to increase the total compensation paid to the contractor during the entire term of the agreement, including renewals thereof. The contractor provides auctioneering and simulcasting services for vehicles, trucks vans, off road vehicles and small powered equipment on an on-call basis.

9. Amendments to Contracts - (3) - Computer training classes for county employees - OHR

Three amendments to the contracts with Answer Quest Technologies, Inc., The Board of Trustees of The Community College of Baltimore County, and Logical Ventures, Inc., T/A Systems Source, to add an additional renewal period to the existing agreements, in order to have addition time to rebid the contracts. The contractors currently provide computer training classes for Baltimore County employees.

Councilmembers Quirk and Olszewski commented on Fiscal Matter 6. There being no further discussion, upon motion by Councilman Olszewski, seconded by Councilman Quirk, Fiscal Matters 1 through 9 were unanimously approved.

G. <u>MISCELLANEOUS BUSINESS</u>

1. Correspondence - Non-Competitive Awards

At the direction of the Chairman, the Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during June, 2014.

2. Res. 57-14 - Review of Planned Unit Development - Towson Mews

At the direction of the Chair, the Secretary read this Resolution of the Baltimore County Council to approve the review of a proposed planned unit development in accordance with County law. Councilman Mars commented. There being no further discussion, upon motion by Councilman Marks, seconded by Councilman Huff, this Resolution was unanimously approved.

3. Res. 58-14 - Endorsement of Application - Greater Dundalk/Sparrows Point Sustainable Community - Turners Station area

At the direction of the Chair, the Secretary read this Resolution to approve the application and receipt of financing for a Community Legacy Project further described in the Community Legacy Application, to be financed either directly by the Department of Housing and Community Development of the State of Maryland or through other departments or agencies of the State of Maryland. Andrea Van Arsdale appeared. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Marks, this Resolution was unanimously approved.

4. Res. 59-14 - Endorsement of Application - MD Community Investment Tax Credit Program - United Ministries

At the direction of the Chair, the Secretary read this Resolution to endorse the application of the United Ministries, Inc. ("United Ministries") to the State of Maryland Community Investment Tax Credit Program for certain tax credits to provide operating funds. Andrea Van Arsdale remained. There being no discussion, upon motion by Councilwoman Almond, seconded by Councilman Huff, this Resolution was unanimously approved.

5. Res. 60-14 - Expansion of Residential Parking Area - "B" - Southland Hills - Towson

At the direction of the Chair, the Secretary read this Resolution to expand Residential Permit Parking area, in accordance with the procedures of Section 18-4-402, of the Baltimore County Code, 2003, for the area of Southland Hills in West Towson outlined on the attached plat. Ed Adams appeared. Councilman Marks commented. There being no further discussion, upon motion by Councilman Marks, seconded by Councilman Oliver, this Resolution was unanimously approved.

6. Res. 61-14 - Property Tax Exemption - DAV - Michael C. Papier

At the direction of the Chair, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Michael C. Papier who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Quirk, seconded by Councilman Olszewski, this Resolution was unanimously approved.

7. Res. 62-14 - Property Tax Exemption - Surviving Spouse - Alva V. Henson

At the direction of the Chair, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Alva V.
