<u>Bill 35-16</u>, Prohibition on Outdoor Smoking, was called. Councilman Kach commented then moved to amend this Bill with the following amendments:

- 1. On page 1, in lines 1 and 2 of the Purpose paragraph, strike "prohibiting outdoor smoking in certain areas of golf course facilities owned and operated by" and substitute "requiring", and in line 2, after "the Baltimore County Revenue Authority" insert "to identify a certain area of a golf course facility to be reserved for nonsmokers".
- 2. On page 2, in line 4, strike "A PERSON MAY NOT SMOKE WITHIN 30 FEET OF THE DRIVING RANGE OR THE CLUB HOUSE OF ANY GOLF COURSE FACILITY OWNED AND OPERATED BY THE BALTIMORE COUNTY REVENUE AUTHORITY" and substitute the following:

'THE BALTIMORE COUNTY REVENUE AUTHORITY SHALL:

- (1) DESIGNATE AT ITS GOLF TRAINING CENTER FACILITY, AND IDENTIFY WITH APPROPRIATE SIGNAGE, AN AREA OR AREAS THAT ARE RESERVED FOR PARTICIPANTS WHO ARE NONSMOKERS; AND
- (2) IMPLEMENT A POLICY THAT ENCOURAGES CONSIDERATION FOR NONSMOKERS AT IS DRIVING RANGE FACILITIES."

The motion failed for lack of second. The bill was laid on the table.

<u>Bill 36-16</u>, Social Host - Unruly Social Gatherings, was called. Councilman Marks commented then moved to amend this Bill with the following amendment:

On page 2, in line 9, strike "EAST" and substitute "WEST".

Councilman Quirk seconded the motion and this amendment passed by the following roll call vote:

Thereafter, upon motion by Councilwoman Bevins, seconded by Councilman Quirk, Bill 36-16, as amended, passed by the following roll call vote:

<u>Bill 37-16</u>, Employees' Retirement System - Contribution rates, was called. Councilman Quirk moved to amend this Bill with the following amendment:

On page 8, line 3 and page 11, line 3, strike "PARAGRAPH" and substitute "SUBPARAGRAPH".

Councilman Jones seconded the motion and this amendment passed by the following roll call vote:

# F. APPROVAL OF FISCAL MATTERS

The Chairwoman stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on May 10, 26. The witnesses who testified at the work session were available to restate their testimony if needed. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Chairwoman Almond then called upon the Secretary to read the cover letters for Fiscal Matters 1 through 4.

#### 1. Contract - Hollins Organic Products, Inc. - Yard waste processing services - PW

A contract with Hollins Organic Products, Inc., to provide yard waste processing services at the Baltimore County central acceptance facility, resident's drop off area.

# 2. Contract - Tito Contractors, Inc. - On-call painting services - OBF

A contract with Tito Contractors, Inc., to provide on-call painting services at various county-owned and/or operated building, to include all labor, materials, tools, equipment and supervision.

# 3. <u>Contract - Multicorp Fire Protection Services, LLC-Fire extinguisher and fire</u> suppression system maintenance - OBF

A contract with Multicorp Fire Protection Services, LLC, to provide fire extinguishers and fire suppression systems maintenance, to include all inspections, testing, labor, materials, tools, equipment and supervision.

# 4. Contract - Broadview Waste Services, Inc. - Pick-up and recycling of fluorescent light bulbs - DEPS

A contract with Broadview Waste Services, Inc., to provide for the pick-up and recycling of fluorescent light bulbs from county residents, as well as county government buildings.

There being no discussion, upon motion by Councilman Quirk, seconded by Councilwoman Bevins, Fiscal Matters 1 through 4 were unanimously approved.

# G. MISCELLANEOUS BUSINESS

# 1. Correspondence - Non-Competitive Awards

At the direction of the Chairwoman, the Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during April, 2016.

# 2. Res. 51-16 - Planned Unit Development - Red Run Reserve

At the direction of the Chairwoman, the Secretary read this Resolution of the Baltimore County Council to approve the review of a proposed planned unit development in accordance with County law. Councilman Jones commented. There being no further discussion, upon motion by Councilman Jones, seconded by Councilman Quirk, this Resolution was unanimously approved.

# 3. Res. 54-16 - Renaming portion of Baisman Run - Wolman Run

This Resolution was withdrawn.

### 4. Res. 55-16 - Accept monetary gift - State of MD PSCS-ENSB - 911 Center

At the direction of the Chairwoman, the Secretary read this Resolution to authorize the County to accept a gift of money from the State of Maryland Department of Public Safety and Correctional Services, Emergency Number Systems Board. Keith Dorsey appeared. Councilman Jones commented. There being no further discussion, upon motion by Councilwoman Bevins, seconded by Councilman Crandell, this Resolution was unanimously approved.

#### 5. Res. 56-16 - Accept monetary gift - State of MD PSCS-ENSB - 911 Center

At the direction of the Chairwoman, the Secretary read this Resolution to authorize the County to accept a gift of money from the State of Maryland Department of Public Safety and Correctional Services, Emergency Number Systems Board. Keith Dorsey remained. Councilman Jones commented. There being no further discussion, upon motion by Councilman Jones, seconded by Councilwoman Bevins, this Resolution was unanimously approved.

#### 6. Res. 57-16 - Applications - (5) - Rural Legacy Area Plan

At the direction of the Chairwoman, the Secretary read to rank five Rural Legacy Area Plan applications submitted to the Maryland Department of Natural Resources for consideration and approval by the Maryland Rural Legacy Board for funding in fiscal year 2017. These plans include the Baltimore County Coastal, Gunpowder Valley, Long Green Land Trust, Manor, and Piney Run Watershed. Wally Lippincott appeared. Councilwoman Bevins appeared. There being no further discussion, upon motion by Councilman Jones, seconded by Councilman Quirk, this Resolution was unanimously approved.

#### 7. Res. 58-16 - Payment in lieu of taxes - authorize written agreement - AHC Dunfield LLC

This Resolution was deferred to a later date.

At the direction of the Chairwoman, the Secretary read to endorse the application of Warren Square, LLC. ("Warren Square Shopping Center") to the Maryland Department of Housing and Community Development ("DHCD") Neighborhood BusinessWorks Program ("NBW"). Andrea Van Arsdale appeared. There being no discussion, upon motion by Councilman Jones, seconded by Councilman Quirk, this Resolution was unanimously approved.

#### 9. Res. 60-16 - Issuance and sale of bonds - The Montessori Society of Central MD, Inc.

At the direction of the Chairwoman, the Secretary read this Resolution authorizing and providing for the issuance and sale by Baltimore County, Maryland, pursuant to the Maryland Economic Development Revenue Bond Act. Will Anderson appeared. There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilman Quirk, this Resolution was unanimously approved.

#### 10. Res. 61-16 - Property Tax Exemption - DAV - Robert L. Smith

At the direction of the Chairwoman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Robert L. Smith, who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Jones, seconded by Councilman Crandell, this Resolution was unanimously approved.

# 11. Res. 62-16 - Property Tax Exemption - DAV - Lance E. Griffin

At the direction of the Chairwoman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Lance E. Griffin, who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. At the direction of the Chairwoman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Herschel M. Burley, who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. # 13. Res. 64-16 - Property Tax Exemption - DAV - Thomas M. Rush, Jr.

At the direction of the Chairwoman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Thomas M. Rush, Jr., who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Marks, seconded by Councilman Quirk, this Resolution was unanimously approved.

#### 14. Res. 65-16 - Property Tax Exemption - DAV - George C. Lowery

Lowery, who is entitled to an exemption from real property taxes by reason of the exemption afforded to disabled veterans under State law.
