B. APPROVAL OF JOURNAL

Upon motion by Councilman Jones, seconded by Councilwoman Bevins, the reading of the Journal Entries for the meeting of June 5, 2017 was waived and accepted unanimously.

C. ENROLLMENT OF BILLS

The Chairman stated that the following Bill was passed by the County Council and signed by the County Executive. He certified and delivered to the Secretary, Bill 31-17.

D. INTRODUCTION OF BILLS

<u>BILL 42-17</u>, entitled An Act for the purpose of adding a new landmark to the Final Historical Landmarks List; and generally relating to the Baltimore County Historical Landmarks List.

<u>BILL 43-17</u>, entitled An Act for the purpose of permitting a collection bin to be placed on certain private property under certain conditions; defining terms; specifying the properties where a bin may be located; requiring a use permit; requiring the consideration of certain factors prior to the issuance of a permit; providing for conditions to be imposed upon a use permit; authorizing the removal of a bin or the revocation of a permit; and generally relating to the location of collection bins.

<u>BILL 44-17</u>, entitled An Act for the purpose of providing that a medical cannabis dispensary may not be located within a certain distance of property owned by the Baltimore County Board of Education; requiring certain notification; and generally relating to the location of medical cannabis facilities.

BILL 45-17, entitled An Act for the purpose of limiting the proximity of assisted-living facilities I and II to other such facilities; and generally relating to the location of assisted-living facilities.

- "1. INTERIOR SPACE FOR MANUFACTURING/WAREHOUSE USES ASSOCIATED WITH BREWERY OPERATIONS, INCLUDING OFFICES AND STORAGE: 1 SPACE PER EMPLOYEE ON LARGEST SHIFT
- 2. INTERIOR SPACE FOR ACCESSORY OR AUXILIARY USES THAT IS ACCESSIBLE TO THE PUBLIC.
- A. AREA DEVOTED TO FOOD OR BEVERAGE SERVICE: 10 SPACES PER 1,000 SQUARE FEET OF GROSS AREA.
- B. AREA DEVOTED TO ACCESSORY OR AUXILIARY USES OTHER THAN FOOD OR BEVERAGE SERVICE: 5 SPACES PER 1,000 SQUARE FEET OF GROSS FLOOR AREA.
- 3. NOTWITHSTANDING THE ABOVE PARKING REQUIREMENTS, ON APPLICATION, THE DIRECTOR OF THE DEPARTMENT OF PERMITS, APPROVALS AND INSPECTIONS MAY APPROVE A REDUCTION IN THE AMOUNT OF PARKING REQUIRED UPON A SHOWING THAT THE PARKING PROVIDED ONSITE IS SUFFICIENT FOR THE USES PROPOSED OR THAT SUFFICIENT OFFSITE PARKING WILL BE PROVIDED WITH TRANSPORTATION BEING PROVIDED TO AND FROM THE OFFSITE PARKING."
- 3. On page 5, in the column labeled "Maximum area/Face", strike the word "FAÇADE" in three instances.

On page 4, in line 13, after "TO", insert "THE FOLLOWING SOLAR FACILITY INSTALLATIONS"; in line 14, after "A", insert "GROUND-MOUNTED"; in lines 14, 15, and 16, strike "LOCATED IN A YARD AREA, BUILDING, OR STRUCTURE THAT IS ACCESSORY TO A PRINCIPAL RESIDENTIAL, AGRICULTURAL, COMMERCIAL, OR INDUSTRIAL USE" and substitute "THAT IS ACCESSORY TO A PRINCIPAL RESIDENTIAL OR AGRICULTURAL USE (SUBJECT TO SECTIONS 400.1 AND 400.2 OF THESE REGULATIONS APPLICABLE TO ACCESSORY BUILDINGS), OR ACCESSORY TO A PRINCIPAL COMMERCIAL, INDUSTRIAL, OR INSTITUTIONAL USE"; after line 16, insert "2. A ROOFTOP SOLAR FACILITY;"; in line 17, strike "2" and substitute "3"; in line 19, strike "3" and substitute "4"; in line 19, after "FACILITY", insert "LOCATED ON THE SAME PROPERTY OR TRACT AS A FARM"; in line 20, after "USES", insert "ON THE FARM".

Councilwoman Bevins seconded the motion and these amendments passed by the following roll call vote:

Councilman Marks then moved to amend this Bill with the following amendments:

- 2. On page 4, in line 13, prior to "THIS", insert "A."; after line 20, insert "B. PRIOR TO EXECUTION OF A PROPOSED LEASE OF COUNTY OWNED LAND OPERATED BY THE DEPARTMENT OF RECREATION AND PARKS FOR A SOLAR FACILITY UNDER PARAGRAPH A.2 OF THIS SECTION, THE ADMINISTRATIVE OFFICER SHALL SEND WRITTEN NOTIFICATION TO THE COUNCIL MEMBER IN WHOSE DISTRICT THE FACILITY IS PROPOSED. THE COUNCIL MEMBER SHALL HAVE 14 DAYS FROM RECEIPT OF THE NOTICE TO REQUEST THAT THE LEASE BE PRESENTED TO THE COUNTY COUNCIL AT ITS NEXT LEGISLATIVE SESSION."

Councilman Kach seconded the motion and these amendments failed by the following roll call vote:

1. On page 1, in line 23, after "DISTRICT.", insert "A COUNCILMANIC DISTRICT SHALL BE DEFINED AS THE COUNCILMANIC DISTRICT IN FORCE AS OF THE 2014 ELECTION. OF THE TEN (10) SOLAR FACILITIES SHALL BE LOCATED ON R.C. ZONED LAND IN EACH DISTRICT.

- 2. On page 4, after line 10, insert "C. BEFORE A PROPOSED SOLAR FACILITY CAN BE APPROVED, EACH RESIDENTIALLY USED PROPERTY WITHIN 500 FEET AND WITH A VIEW OF THE PROPOSED SOLAR FACILITY SHALL GIVE WRITTEN APPROVAL. WRITTEN APPROVAL SHALL NOT BE UNREASONABLY WITHHELD AND ANY DISPUTE FROM THIS PARAGRAPH SHALL BE ADJUCIATED BY THE ADMINISTRATIVE LAW JUDGE DURING THE SPECIAL EXCEPTION HEARING.".
- 3. On page 6, in line 7, after "CODE", insert ", AND SHALL INCLUDE ADEQUATE BUFFERS TO PROJECT NATURAL STREAMS AND WATERWAYS FROM DEGRADATION OF AQUATIC WILDLIFE AS A RESULT OF STORMWATER RUNOFF".
- 4. On page 9, after "October 18, 2016", insert "except that the limits on the number of solar facilities in each Councilmanic District in Section 4E-102.B shall apply to any zoning petition filed on or before that date".

Councilman Marks seconded the motion, Councilman Kach then moved to separate his proposed amendments.

F. APPROVAL OF FISCAL MATTERS

The Chairman stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on June 27, 2017. The witnesses who testified at the work session were available to restate their testimony if needed. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Chairman Quirk then called upon the Secretary to read the cover letters for Fiscal Matters 1 through 10.

1. Contracts – (2) – On-call landscape architectural/civil engineering services – OBF

Two contracts with Site Resources, Incorporated and Whitney Bailey Cox & Magnani, to provide on-call landscape architectural/civil engineering services.

2. <u>Contract – Bel Air Auto Auction, Inc. – Sale of county-owned vehicles, trucks & equipment – DPW</u>

A contract with Bel Air Auto Auction, Inc., to provide for the sale of retired County-owned vehicles, trucks and equipment. The contractor shall be responsible for the auctioneering and simulcasting services of vehicles, trucks and equipment.

3. <u>Contract – Energ Wellness Solutions, LLC – Maintenance and repair of exercise equipment – AGING</u>

A contract with Energ Wellness Solutions, LLC, to provide maintenance and repair of exercise equipment at various sites of the Department of Aging, Police Department and Fire Department.

4. Amendment #3 to Contract - Community Assistance Network, Inc. - Operation of homeless shelter facilities-DP

Amendment #3 to the contract with Community Assistance Network, Inc., to extend the current term by one year; and to increase the total compensation amount. The Contractor will continue to operate shelter facilities for the homeless in Baltimore County.

5. Amendment #2 to Contract – St. Vincent de Paul of Baltimore, Inc. – Operation of Hannah More shelter-DP

Amendment #2 to the contract with Vincent de Paul of Baltimore, Inc., to extend for one year its current term; and to increase the total compensation amount. The contractor will continue to operate the Hannah Moore shelter, located in Owings Mills, Maryland, for the homeless in Baltimore County.

6. Contracts – (2) – Pest control services – Rat eradication services – PAI

Two contracts with Daniel Purdie d/b/a Big Dan the Pest Man Pest Control and Solomon's Exterminating, Inc., d/b/a Solomon's Termite & Pest Control, to provide pest control services, to control, reduce and/or eradicate rat populations in County communities on an on-call, as-needed basis.

7. Contracts – (4) – On-call professional services – Various title searches for County projects – PAI

Four contracts to provide on-call professional services for performing various types of title searches for various Baltimore County projects.

8. <u>Contract of Sale – Linda Lee & Robert Lee Johnson – Lots 113 & 114, Block K,</u> Delaware Ave., 21227 – REC

A contract of sale with Linda Lee and Robert Lee Johnson, to purchase a parcel of land, located on Lots 113 & 114, Block K, Delaware Avenue, Baltimore, Maryland 21227; to replace the force main with new 60" force main.

9. <u>Contract of Sale – Tito Realty, c/o Home Sales Co. – Stormwater Mgt. easement rights-Campbell Blvd./Bird River Rd.-REC</u>

A contract of sale with Tito Realty, c/o Homes Sales Co., to purchase stormwater management easement rights across Campbell Boulevard and Bird River Road, so that the County can have access whenever needed.

10. Amendment #2 to Contract -WB Services, LLC - Hauling of waste to various transfer facilities - DPW

Addendum #2 to the contract with WB Services, LLC, to extend the scope of work to add the hauling of MSW from the Western Acceptance Facility (WAF) to BRESCO and hauling of yard material from WAF to the Eastern Sanitary Landfill, due to the termination of the Maryland Environmental Services contract.

There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilman Jones, Fiscal Matters 1 through 10 were unanimously approved.

G. MISCELLANEOUS BUSINESS

1. Correspondence - Non-Competitive Awards

At the direction of the Chairman, the Deputy Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during May, 2016.

2. Memorandum of Understanding – Maryland Judiciary, Administrative Office of the Courts & Circuit Court-Duress Alarm Upgrade

At the direction of the Chairman, the Secretary read this Memorandum of Understanding between the Maryland Judiciary, Administrative Office of the Courts and Circuit Court for Baltimore County, Maryland to provide a duress alarm upgrade. Tim Sheridan appeared. There being no discussion, upon motion by Councilman Jones, seconded by Councilwoman Almond, this Memorandum of Understanding was unanimously approved.

3. Res. 60-17 - Property Tax Exemption - BLIND - William S. Barnes

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from William S. Barnes, who is entitled to a partial exemption from State and County real property taxes by reason of the exemption afforded to blind persons under State law. There being no discussion, upon motion by Councilman Jones, seconded by Councilman Quirk, this Resolution was unanimously approved.

4. Appointment - Chief - Fire Department - Kyrle W. Preis, III

At the direction of the Chairman, the Secretary read this correspondence from the County Executive requesting the appointment of Kyrle W. Preis III as the Fire Chief of the Baltimore County Fire Department for the remainder of his term. Councilmembers Marks, Bevins and Jones commented. There being no further discussion, upon motion by Councilwoman Bevins, seconded by Councilwoman Almond, this appointment was unanimously approved.

5. Appointment – Baltimore County Ethics Commission – Lee Jacobson, Esq.

At the direction of the Chairman, the Secretary read this correspondence from the County Executive requesting the appointment of Lee Jacobson, Esq. to the Baltimore County Ethics Commission for a three year term effective July 1, 2017. There being no discussion, upon motion by Councilman Jones, seconded by Councilwoman Almond, this appointment was unanimously approved.

6. Reappointments – (2)– Baltimore County Ethics Commission – Susan R. Green/Jeffery L. Forman

At the direction of the Chairman, the Secretary read this correspondences from the County Executive requesting the re-appointments of Susan R. Green and Jeffrey L. Forman to the Baltimore County Ethics Commission for a three year term effective July 1, 2017. There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilwoman Almond, these re-appointments were unanimously approved.

7. Appointment – Baltimore County Ethics Commission – Chairman – Jeffery L. Forman

At the direction of the Chairman, the Secretary read this correspondence from the County Executive requesting the appointment of Jeffrey L. Forman as Chairman of the Baltimore County Ethics Commission. Upon confirmation Mr. Forman's term as Chairperson of the Ethics Commission would run concurrently with his present term of membership, expiring on June 30, 2020. There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilwoman Almond, this appointment was unanimously approved.

8. Res. 61-17 – Property Tax Exemption – BLIND – Charles Geyer

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Charles Geyer, who is entitled to a partial exemption from State and County real property taxes by reason of the exemption afforded to blind persons under State law. There being no discussion, upon motion by Councilwoman Bevins, seconded by Councilman Quirk, this Resolution was unanimously approved.
