AN ACT concerning

Basic Services Maps

FOR the purpose of repealing the Basic Services Sewerage Map, the Basic Services Water Supply Map and the Basic Services Transportation Map; and adopting a new Basic Services Sewerage Map, a new Basic Services Water Supply Map and a new Basic Services Transportation Map; and requiring the maps to be posted online.

By repealing and reenacting, with amendments
Subsection 4A02.3.A.1.,2. and 3.
Baltimore County Zoning Regulations, as amended

BY repealing
2011 Basic Services Sewerage Map
2011 Basic Services Water Supply Map
2011 Basic Services Transportation Map, all as adopted by Bill No. 15-11

BY adopting the new
2012 Basic Services Sewerage Map
2012 Basic Services Water Supply Map
2012 Basic Services Transportation Map

WHEREAS, in accordance with Subsection 4A02.3.E. of the Baltimore County Zoning Regulations, the Planning Board has recommended revisions to the Basic Services Maps and submitted those recommendations to the County Council on March 1, 2012, and the County Council has held a public hearing thereon on April 2, 2012; now, therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Basic Services Maps referred to in Subsections 4A02.3.A.1., 2.
3 and 3. of the Baltimore County Zoning Regulations, and further identified as (1) 2011 Basic Services
4 Sewerage Map, (2) 2011 Basic Services Water Supply Map; and (3) 2011 Basic Services
5 Transportation Map, and any amendments and revisions previously made thereto are hereby
6 repealed.

7 SECTION 2. AND BE IT FURTHER ENACTED, that the Basic Services Maps identified
8 herein and accompanying this Act are hereby adopted and declared to be a part of this Act and
9 incorporated by reference herein. The following maps are hereby adopted and identified as follows:

- 10 1. 2012 Basic Services Sewerage Map;
- 11 2. 2012 Basic Services Water Supply Map; and
- 12 3. 2012 Basic Services Transportation Map

13 SECTION 3. AND BE IT FURTHER ENACTED, that upon the effective date of this Act,
14 the Maps adopted hereby shall be signed by the Chairman of the County Council and shall be dated
15 as of the effective date of this Act and thereafter delivered to the Zoning Commissioner of Baltimore
16 County for custody.

1 SECTION 4. AND BE IT FURTHER ENACTED, that Subsection 4A02.3.A.1., 2. and 3.
2 of the Baltimore County Zoning Regulations, be and they are hereby repealed and reenacted, with
3 amendments, to read as follows:

4 Section 4A02.3 - Basic Services Maps
5 4A02.3 - Adoption of Basic Services Maps

6 A. The following basic services maps, which shall be in the custody of the Zoning
7 Commissioner for Baltimore County AND POSTED ON THE COUNTY'S INTERENET
8 WEBSITE, are hereby adopted and made a part of this Article:

- 9 1. [2011] 2012 Basic Services Sewerage Map
- 10 2. [2011] 2012 Basic Services Water Supply Map
- 11 3. [2011] 2012 Basic Services Transportation Map

12 SECTION 5. AND BE IT FURTHER ENACTED, that this Act, having been passed by the
13 affirmative vote of five members of the County Council, shall take effect on May 21, 2012.
